Under running water, remove contaminated clothing, shoes and leather goods (e.g. watchbands and belts) and completely decontaminate them before reuse or discard. If irritation persists, repeat flushing and seek medical attention.

7. HANDLING AND STORAGE

Available information suggests that gloves made from should be suitable for intermittent contact.
