4. FIRST AID MEASURES

Immediately flush the contaminated eye(s) with lukewarm, gently flowing water until the product is removed or until a few minutes after irritation has ceased, while holding the eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

SMALL SPILLS
